



RELEASE AND WAIVER OF LIABILITY

I agree to defend, indemnify, and hold harmless Members and all of their officers, managers, affiliated organizations, agents, employees, successors and assigns for any injury or death caused by or resulting from my participation in the Activities provided by Members whether or not such injury or death was caused by or resulting from their negligence or any other cause.

This contract shall be legally binding on me, my estate, heirs, assigns, legal guardians, and personal representatives. I have carefully read the above and fully understand its contents. I am aware that I am releasing certain rights that I may have, and enter into this contract of my own free will.
